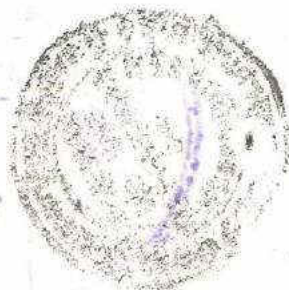

Now this Deed of Trust witnesseth as follows:

1. The name of the Trust shall be "A. D.S. Educational Trust" hereinafter referred to as "Institute".

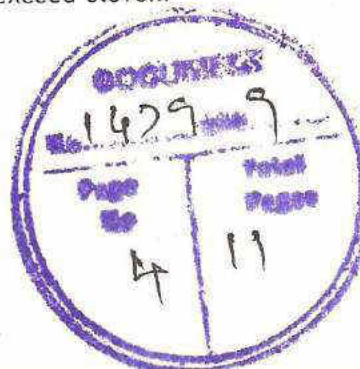

2. The First Trustees are:

- Smt A. Alli
- Shri A. Arockiadass
- Shri B. Arulsamy

All the above Trustees shall hold office for their life. They will have the right to co-opt any other person for life or for a fixed term by consensus of all or by two thirds majority of total strength of the Board of Trustees. However, the total number of Trustees shall at no time exceed eleven.

3. The Registered Office of the Institute shall be situated at G-4, Salma Sanjana Castle, No. 185, Choolaimedu High Road, Choolaimedu, Chennai - 600 094 or such other place as may be found suitable from time to time.

4. Main Objects:

- a. To provide for Instruction and Training in various branch of learning as it may deem fit.
- b. To provide for research and for the advancement of and dissemination of knowledge.
- c. To undertake extra moral studies, extension programmes and field outreach activities to contribute to the development of the society.
- d. To do all such other acts and things as may be necessary or desirable to further the objectives of the Institute.

5. Other Objects and Functions:

To carry out the above objectives and for the management of properties of the Institute, the Institute shall have the following powers:

- a. To establish courses of study and research and to provide instruction and training in such branches of study as the Institute deems appropriate for the advancement of learning and dissemination of knowledge in such branches.
- b. To confer degrees and to grant diplomas and / or certificates to persons who have satisfactorily completed the approved courses of study and / or research, as may be prescribed and shall have passed the prescribed examinations.
- c. To institute and award visitorship, fellowship, exhibits, prizes and medals.
- d. To have greater interface with the society and to have freedom to enlarge and enrich the programme offerings.
- e. To further contribute to the cause of higher education by reaching out to socially, economically and physically disadvantaged.
- f. To start schools and centers of excellence, departments and institutions in Engineering Technology, Medicine and Natural and Applied Sciences and Arts, Media Performing Arts and Teaching and Physical Education and Dental and in other facilities and based on the social and industrial needs.
- g. To establish and run schools, colleges, industrial, technical, professional institutions, B Schools and Residential School of Institution.
- h. To provide children kinder garden education by conducting classes.

- i. To establish and run Environmental Institutions, Laboratories and Documentation Centers.
- j. To render all possible help for the Special children such as blind, deaf and dumb, physically handicapped and mentally challenged whenever they approach and seek help for education according to their constitution and learning capacity.
- k. To arrange to study and promote the International Art, Sports and Games, Meditation and Exercise.
- l. To run hospitals, health education centers or other institutions or Institution for Leprosy or handicapped or education of AIDS institution for the reception and treatment of persons suffering from illness or mental defectiveness of for the reception and treatment of persons during convalescence or of persons requiring medical attention of rehabilitation solely for philanthropic purchase and not for purposes of any gain or profit.
- m. To introduce programmes of Research and Training in identified areas of national priorities in global context from time to time.
- n. To set up special institutes such as community colleges and rural institutes etc. and offer need based courses to the benefit of the community at large.
- o. To establish tie up with foreign university / institutions for the purpose of exchange of faculty and transfer of technology.
- p. To conduct periodic lectures, meetings, conferences, seminars and surveys on matters of interest to national and international weaker sections of the people.
- q. To establish branches, offices, regional committee, local committees and the life and to initiate inter groups and inter state projects and enable local groups and branches of social welfare organizations to carry them out.
- r. To establish and maintain research and reference libraries, reading rooms, study classes, hotels and centers, for a study recitations and welfare for the benefit of the socially, economically and educationally down trodden people.
- s. It is specifically declared that the Trust shall exist solely and exclusively for educational purpose and not for profit.

6. Institute open to All:

- a. The Institute shall be open to all persons of all classes and the geographical area of the country.
- b. No capitation fee shall be charged in any form in consideration for admission.

- c. Fees to be prescribed shall be as recommended by a Committee of Experts to be appointed in consultation with the UGC or respective Government / Nodal Authorities / Bodies / Agencies.
- d. No benefaction shall be accepted by the Institute, which in its opinion involves conditions and obligations opposed to the spirit and subjects of this section.

7. Admissions:

Admissions shall be made on all India basis of all programmes / courses of the Institutions through a common entrance test based on the policy declared from time to time.

The Institute shall retain the legal status of the College / Educational Institutions / Trust as a Christian Minority Institution and shall continue to avail the benefits under the relevant rules.

8. Income and Property of the Institute:

For Income and property of the Institute, however derived, shall be applied towards the promotion of the objectives thereof as set forth in this Trust Deed.

No portion of the income and property of the Institute shall be paid or transferred directly or indirectly by way of profit, to the persons, who at any time, or have been members of the Institute or to any of them provided that nothing herein contained shall prevent the payment in good faith of remuneration to any member thereof or other person in return for any service rendered to the Institute.

9. Reviews and Inspection:

The Central Government shall have the right to cause an inspection to be made of the Institute, its buildings, its examinations, teaching and other work conducted or done by the Institute and to cause an enquiry to be made, if considered necessary by the Central Government in respect of matter connected with the Institute.

10. The Trust is Irrevocable.

11. Accounts of the trust will be maintained regularly and the same will be audited by "Chartered Accountant" every year.

12. On dissolution of the Trust, the net Assets of the Trust will be transferred to some other Trust having similar objects.

13. Constitution of the Trust Board:

The Trust Board shall consist of 5 Members three members from the Board of Trustees and two from general public. The member from general public will be appointed as Governing Body Members in the Annual / Extra-ordinary General Meeting of the Trust and they will hold office for three years.

14. Powers of the Founder and Managing Trustee:

Founder of the Trust shall be the Executive Head of the Trust and the Trust Board. She shall preside over meetings. Further she shall -

- a. To manage all the affairs of the Institute.
- b. To convene Trust Board Meetings
- c. To incur expenses accounting to the budget and produce receipt and accounts thereof in each Trust Board meeting.
- d. To enter into correspondence with related activities
- e. To manage the trust fund and collect and recover the interest, dividends and other income thereof any to pay and discharge out of the income of the trust fund all expenses and charges for collecting and recovering the income of the trust fund and all other costs, charges and expenses and out going of and incidental to the trust created by their presents and the administration thereof.
- f. To pay or utilize the income of the trust called the net income of the trust and at the discretion of the trustees the corpus of the Trust set out hereinabove in such shares and properties and in such manner in all respects as the trustees shall in their absolute discretion think fit. The trustees shall have all the power necessary or incidental for effectual carrying out the objects of the Institute.
- g. To apply the trust money to effectuate one object or some of the objects of the Institute in preference to other objects. To discontinue the applications of trust funds to the objects and divert the funds to objects of the trust.
- h. In case it is decided to render financial or other aid to any persons or institutions within the scope of the objects, to decide the terms and conditions which shall be complied with by such persons or institutions.
- i. To determine if necessary, the terms and conditions on which any donation, subscriptions, scholarships or prizes or medals are to be given by the Institute.
- j. To expand the funds of trust in such manner as they consider must beneficial for the objects and purposes of the Institute.
- k. To acquire agricultural lands, vacant properties, build upon, pull down, rebuild, add to, alter, repair, cultivate or improve, sell or dispose of any land, building or premises for the use of Institute and to acquire other movables and tangible and intangible benefits of immovable properties.
- l. To take any property on lease or hire.
- m. To let on hire or lease and transfer any movable or immovable properties not immediately required by the Institute.

- n. To acquire any property in exchange for some other property or partly in such exchange and partly for other considerations.
- o. To accept any movable or immovable properties by way of gift, donations and other means from persons, firms, Companies or Trust with similar objects.
- p. To enter into any contract on behalf of the Institute.
- q. To borrow money upon the security of any of the property of the Institute on the terms and conditions for the purposes of the objects of the Institute and in such case the Trustees shall not borrow funds exceeding 75% of the market value of the properties of the Institute.
- r. To make and from time to time repeal, add or alter regulations -
- s. As to the management of trust and affairs thereof.
- t. As to the duties and responsibilities of trustees
- u. As to conduct any of the matters of things that will be under the control of the trustees provided the same shall not be in consistent with the provisions contained in these presents.
- v. To settle out court compromise or compound all suit actions and other proceedings.
- w. To appoint and remove managers, secretary, clerks and other staff and workers required for the working for general management of the affairs of the Institute.

15. Meetings of the Board:

- a. The Board shall hold an annual meeting for the purpose of the approving the audited financial statement of accounts.
- b. The Board shall transact any business that may be specified in the Agenda or otherwise agreed to by the Board of Trustees.
- c. The Board shall also appoint an Auditor at the annual meeting for the subsequent years.
- d. Three Trustees / Members of the Board shall constitute the quorum.
- e. The meeting of the Board shall be convened after giving at least one week notice unless those who are entitled to receive notice agree to accept the shorter notice.
- f. All those activities of the meeting shall be properly minuted and signed by the Founder Trustee & Managing Trustee and Financial Trustees.

16. Accounts & Audit:

- a. Proper and regular books of accounts of all Receipts and Payments, Income and Expenditure of the Institute shall be maintained by the members either in English or in Tamil.
- b. On the 31st March of every year, a general account shall be taken for all the assets and liabilities of the Institute and an Income & Expenditure account for the whole year and the Statement of Affairs as on 31st March shall be prepared and shall be passed by the Board Members. The accounts of the Institute shall be audited annually by a Chartered Accountant appointed by the Board of Members for the purpose.

17. Bank Account:

The Institute shall operate bank account or accounts in the name of the Institute with any bank or banks. The Founder - Managing Trustee is authorised to open Current / Savings Bank Account or any other type of account in any bank or banks as deemed fit and to operate the same and to execute the necessary documents for receiving loans through banks and the documents so executed by the Board of all Trustees.

18. Amendments & Alternations:

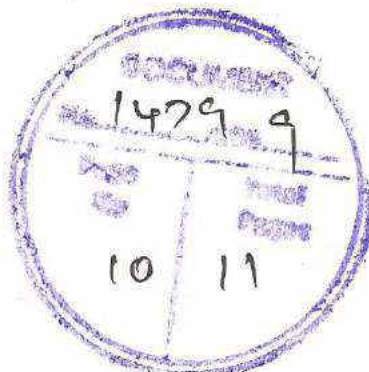
While this deed of trust shall be irrevocable the Board may amend the clauses relating to the membership and the management at a duly convened meeting of the Board and by a resolution passed by three fourth majority of which meeting at least 15 days written notice has given.

19. Extinction of Trust:

In case it becomes necessary to wind-up or otherwise determine this institute for whatever reason, neither the settler nor her heirs nor the Trustees for the time being nor any other person shall have any manner of right over such funds of the institute or any other property. The net funds and other assets, if any, after meeting, all liabilities will be handed over to any other similar institute or Institution similarly satisfying requirements of the Income-tax Act, 1961 as may be decided by the last Trustees subject further to the condition that it shall be so given to an Institution as approved by the Commissioner of Income-tax or Director of Exemptions as the case may be.

20. Legal:

The Founder and Financial Trustees herein may maintain a list of properties acquired, administered and maintained by the Institute and the same always best with all the Trust Board Members.

21. Advisory Board:

The Founder and Financial Trustees herein may maintain a list of advisers for better administration of any particular objects by engaging the services of the said advisers. The trustees shall have liberty to fix remuneration for the services rendered by the advisers.

22. General:

- a. In the event of closure or winding up or dissolution of the Trust, all its assets and liabilities if any shall be transferred to another trust which has similar objects and enjoying exemptions u/s 11 and 80G of the Income Tax Act, 1961.
- b. The Institute shall invest its income available for investments from time to time in specific mode of investments as per Section 13 [i] [d] read with Section 13 [ii] [5] of the Income Tax Act, 1961.
- c. The Income and funds of the Institute shall be solely utilized towards the objects of the Institute and no portion of its income shall be utilized for payment to trustees by way of remuneration on honorarium, profit, interest, dividends, etc. as prescribed in Section 13 [1] [c] of the Income Tax Act, 1961.
- d. The funds of the Institute would not be applied for any religious purposes or given to religious institutions.
- e. The activities shall be confined to the Territory of India.

There is no movable or immovable properties in the name of Trust.
